**DIRECTIONS TO VOTERS**

- When applying for a ballot paper an elector shall produce to the Presiding Officer his/her National Identity Card or Passport.
- An elector should vote for candidate(s) of his/her respective category ONLY.
- Each elector will be issued with a ballot paper for his/her category and will be required to vote for not more than the number of candidates specified hereunder by putting a cross (x) opposite the name(s) of the candidate(s) of his/her choice.
- The elector shall fold the ballot paper so that his/her crosses cannot be seen, show the official mark on verso of the ballot paper to the presiding officer and place it in the ballot box.
- If an elector votes for more candidates than the number specified hereunder or places on the ballot paper any mark or writing by which he/she could afterwards be identified, his/her vote/s will be void and will not be counted.
- A representative of a succession or corporate entity (including company and société) should produce documentary evidence to the effect that he/she has been duly authorized to represent such succession, company or société, when applying for a ballot paper.
